NAPIS/OAAPS Data Extracts & Data Entry Best Practices	Kevin Dusenbury	The first year of reporting in OAAPS is behind us. Let's explore the tools, upcoming enhancements, and review some best practices for a successful SPR submission for FFY 2023 and beyond.

We will discuss creating datasets with filters, building basic reports and demonstrating how to save, run and export those reports.
