This was partly due to their limited direct impact on publicly reported outcomes and reimbursement in home health. Additionally, confusing guidance, coupled with the focus on seemingly more impactful M1800 items, led agencies to focus education and attention to other areas. However, recent regulations have highlighted the increasing importance of GG data elements in the future of home health. This session will address the criticality of prioritizing these data elements in your practice and well as a review of a simplified approach to assessment accuracy for this set of functional abilities data elements.
