Session 1: Introduction to HAR

Session 3: Introduction to SQL Basics

- SQL, or Structured Query Language, is the programming language behind report builder. Understanding SQL can have a profound impact on Report Builder's capability. In this session, we cover the basics of SQL, how to write your own queries, and establish a foundation of knowledge that you can build upon.

Session 4: Flattening Data

- Flattening Data is a common request in Reporting, especially when working with Assessments. It is the process of converting Rows of data into Columns. In this session, we will explore different methods of Flattening data, and will include topics such as CTEs, Temp Tables, Advanced Grouping and Window Functions.

Session 5: Client Presentation - Dick Harmon

- Dick Harmon is the Database Administrator for Iowa's Six Area Agencies on Aging and has been a longtime HAR user. In this session, he will talk about his process for writing complex reports, and how he and his Agencies are linking Service data to Assessment data in HAR to meet new State and Federal program evaluation requirements for all service programs such as malnutrition, food insecurity and social isolation.
